

1 COUNCIL RESOLUTION NO. 16-70

2 A RESOLUTION APPROVING GROWTH POLICY AMENDMENT NO. 31 TO APPROVE
3 CHANGES TO THE BUTTE-SILVER BOW COUNTY GROWTH POLICY LAND USE MAP OF
4 THE 1987 BUTTE-SILVER BOW MASTER PLAN; INCORPORATING, BY REFERENCE, THE
5 CHANGES TO THE MAP AND PROVIDING FOR AN EFFECTIVE DATE HEREIN.

6 WHEREAS, this amendment is intended to reflect basic objectives and policies for generalized
7 patterns of future land uses; and

8 WHEREAS, the Planning Board did, on October 27, 2016, hold a public hearing, after due notice,
9 to consider Growth Policy Amendment No. 31 to amend the Butte-Silver Bow County
10 Growth Policy Land Use Map of the 1987 Butte-Silver Bow Master Plan; and

11 WHEREAS, the Planning Board, after reviewing said application and all written and oral testimony
12 both for and against said amendment to amend the Butte-Silver Bow County Growth
13 Policy Land Use Map of the 1987 Butte-Silver Bow Master Plan recommended that
14 Growth Policy Amendment No. 31 be approved; and

15 WHEREAS, the Council of Commissioners did, on November 20, 2016, hold a public hearing, after
16 due notice, to consider Growth Policy Amendment No. 31 at which all interested
17 persons were given an opportunity to be heard; and

18 WHEREAS, the Council of Commissioners did consider all written and oral testimony, both for and
19 against Growth Policy Amendment changes, and deems it to be in the interest of the
20 public health, safety and general welfare of the citizens of Butte-Silver Bow that
21 Growth Policy Amendment No. 31 be approved.

22 NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF COMMISSIONERS OF THE
23 CONSOLIDATED CITY AND COUNTY OF BUTTE-SILVER BOW, STATE OF MONTANA:

24 SECTION 1: That the 1987 Butte-Silver Bow Master Plan be amended to reflect boundary changes of
25 the Official Butte-Silver Bow County Growth Policy Land Use Map as contained in
26 Growth Policy Amendment No. 31

1 SECTION 2: "Growth Policy Amendment No. 31 Adopted by Reference". That the 1987 Butte-Silver
2 Bow Master Plan of the City and County of Butte-Silver Bow, State of Montana, heretofore
3 adopted by the Butte-Silver Bow Planning Board (Planning Resolution No. 4) on the 31st
4 day of July, 1986, and the Butte-Silver Bow Council of Commissioners (Council
5 Resolution No. 914) on the 3rd day of December, 1986, is hereby amended to incorporate
6 the changes as contained in Growth Policy Amendment No. 31 is approved and adopted
7 and incorporated herein by this reference as if the same were set forth herein word-for-
8 word and figure-for-figure; that a true copy of the 1987 Butte-Silver Bow Master Plan, as
9 amended, is annexed hereto and thereby made a part hereof and is identified as Exhibit
10 "A".

11 SECTION 3: REPEALER: That all resolutions or parts of resolutions in conflict herewith are hereby
12 repealed.

13 SECTION 4: EFFECTIVE DATE: This Resolution shall be in full force and effect immediately
14 from and after its passage and approval.


