

**RESOLUTION NO. 20-****A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BENICIA APPROVING THE RESULTS OF THE GENERAL MUNICIPAL ELECTION HELD NOVEMBER 3, 2020**

**WHEREAS**, on November 3, 2020, a consolidated General Municipal Election was held to elect one Mayor, two City Council Members, one City Clerk, one City Treasurer, and adoption of Advisory Measure D; and

**WHEREAS**, notice of the election was given in the time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in the time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

**WHEREAS**, on November 24, 2020, the County of Solano Elections Official certified the results of the canvass; and

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Benicia that the results of the consolidated General Municipal election held in the City of Benicia on November 3, 2020, to elect one Mayor, two City Council Members, one City Clerk, and one City Treasurer, and adoption of Advisory Measure D, are as follows:
