

**RESOLUTION PERTAINING TO APPROVAL OF BUDGET ADJUSTMENT  
#BA076CIP**

**WHEREAS**, Title 5 of the Code of Public Local Laws of Calvert County, Maryland, being Title 5 of *Article 5* of the Code of Public Laws of Maryland (hereinafter, the "Code"), authorizes and empowers the Board of County Commissioners of Calvert County, Maryland (hereinafter, the "Board of County Commissioners") to adopt the Annual Budget and Appropriation Act each year;

**WHEREAS**, the Board of County Commissioners has the authority pursuant to Section 5-103 of the Code to enact certain budgetary adjustments by Resolution;

**WHEREAS**, the Board of County Commissioners has been advised by the Department of Finance and Budget there is a need to transfer funds totaling Thirteen Million Nine Hundred Eighty-One Thousand One Hundred Dollars(\$13,981,100) from the income tax revenue account to: Ward Farm Roundabout and Restrooms; Prince Frederick Community Center (HEB) (FY21 - FY24 County Portion Debt); Lore Oyster House Rehabilitation; General Facilities, including Community Resource HVAC, Flags Pond Center HVAC, Fleet Maintenance HVAC, ADA Transition Plan, Hunting Creek Annex upgrades, Security Upgrades, Calvert Marine Museum Exhibition Bldg. HVAC, Libraries Technology Upgrades, Calvert Pines Washout; and Stabilization Account (Committed Fund Balance);

**WHEREAS**, the Board of County Commissioners has been advised by the Department of Finance and Budget that funds totaling \$13,981,100 are available in the income tax revenue account, and that the Capital Projects benefitting hereby have been approved by the Planning Commission as consistent with the Comprehensive Plan;

**WHEREAS**, a public hearing regarding this Budget Adjustment #BA076CIP was duly advertised in two County newspapers for two consecutive weeks before the public hearing as required by Section 5-103(c) of the Code and held on XXXXXXXX, 2021 at which time the Board of County Commissioners received public comment; and

**WHEREAS**, upon due consideration of the comments of the public and staff and in furtherance of the public health, safety and welfare, the Board of County Commissioners finds that it is in the best interest of the public health, safety and welfare of the citizens of Calvert County, Maryland to adopt Budget Adjustment #BA076CIP as set forth in Exhibit "A," attached hereto and made a part hereof.

**BE IT FURTHER RESOLVED AND ORDAINED**, by the Board of County Commissioners of Calvert County, Maryland, that, in the event any portion of this Resolution is found to be unconstitutional, illegal, null or void, by a court of competent jurisdiction, it is the intent of the Board of County Commissioners to sever only the invalid portion or provision, and that the remainder of the Resolution shall be enforceable and valid, unless deletion of the invalid portion would defeat the clear purpose of the Resolution, or unless deletion of the valid portion would produce a result inconsistent with the purpose and intent of the Board of County Commissioners in enacting this Resolution.

**BE IT FURTHER RESOLVED AND ORDAINED**, by the Board of County Commissioners of Calvert County, Maryland that the foregoing recitals are adopted as if fully rewritten herein.

**BE IT FURTHER RESOLVED AND ORDAINED**, by the Board of County Commissioners of Calvert County, Maryland that this Resolution shall be effective upon recordation and publication of a fair summary.
