

COUNCIL RESOLUTION NO: 17-45

1 A RESOLUTION ESTIMATING AS NEAR AS POSSIBLE THE COST OF  
2 MAINTAINING SPECIAL IMPROVEMENT DISTRICTS NUMBER 401 AND NUMBER  
3 402 FOR THE PURPOSE OF FIRE HYDRANT RENTAL WITHIN THE CITY-  
4 COUNTY OF BUTTE-SILVER BOW, STATE OF MONTANA, FOR THE FISCAL  
5 YEAR 2018 AND PROVIDING FOR AN EFFECTIVE DATE HEREIN.

6 BE IT RESOLVED BY THE COUNCIL OF COMMISSIONERS OF THE CITY-

9 estimate as near as practicable the cost of  
10 maintaining Special Improvement District Number  
11 401 for fire hydrant rental within the City-  
12 County of Butte-Silver Bow, State of Montana, for  
13 the fiscal year 2018, and makes such estimate as  
14 follows:

15 Total Cost of SID 401 \$322,687

16 SECTION 2: That the Council of Commissioners does hereby  
17 estimate as near as practicable the cost of  
18 maintaining Special Improvement District Number  
19 402 for fire hydrant rental within the City-  
20 County of Butte-Silver Bow, State of Montana, for

1 the fiscal year 2018, and makes such estimate as  
2 follows:

3 Total Cost of SID 402 \$110,217
