ORDINANCE NO. 17-3

1 AN ORDINANCE AMENDING CHAPTER 6.12 OF THE BUTTE-SILVER BOW
2 MUNICIPAL CODE (B-SB MC), ENTITLED "CARE, KEEPING AND SALE OF
3 ANIMALS AND DOMESTIC FOWL", AND SPECIFICALLY AMENDING SECTION
4 6.12.020 ENTITLED "SWINE, GOATS, RABBITS AND FOWL" AND PROVIDING
5 FOR AN EFFECTIVE DATE HEREIN.

6 NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF COMMISSIONERS OF
7 THE CITY AND COUNTY OF BUTTE-SILVER BOW, STATE OF MONTANA:

8 SECTION 1: Amendment: Ordinance No. 47 Section 2 and Section
9 6.12.020 of the Butte-Silver Bow Municipal Code (B-
10 SB MC) shall be and are hereby amended to read as
11 follows:

12 "6.12.020 Swine, goats, rabbits and
13 fowl. The keeping of swine, goats, rabbits and
14 fowl within the jurisdictional boundaries shall be
15 limited to lot sizes of five acres or more in
16 area, with the following exceptions:

17 A. Swine, goats, rabbits and fowl may be brought
18 into the jurisdictional area for sale at stock
19 sale yards for slaughter plants and approved

livestock shows and fairs.

B. One female rabbit may be allowed in an area of
nine thousand square feet.

C. One goat may be allowed in any area of twenty
thousand square feet.

D. Fowl, not to exceed a flock of twenty-five, may
be kept in an area of twenty thousand square
feet.

E. One pot-bellied pig may be allowed in an area
of one acre.

1. A license fee of \$25.00 for each pot-
bellied pig residing in the jurisdictional
boundaries shall be paid annually."

SECTION 2: Effective Date. This Ordinance shall be in full
force and effect upon passage and approval.
