1 A RESOLUTION FIXING AND ESTABLISHING METRO SEWER RATES AND SERVICE
2 CHARGES PURSUANT TO THE OPERATION, MAINTENANCE AND CAPITAL
3 IMPROVEMENTS OF THE METRO SEWER SANITARY AND STORM SEWER SYSTEM
4 AND FOR THE OPERATION, MAINTENANCE AND CAPITAL IMPROVEMENT OF THE
5 METRO SEWER TREATMENT PLANT BY THE CITY-COUNTY OF BUTTE-SILVER
6 BOW, MONTANA FOR FISCAL YEAR 2018 AND PROVIDING FOR AN EFFECTIVE
7 DATE HEREIN.

8 BE IT RESOLVED BY THE COUNCIL OF COMMISSIONERS OF THE CITY-COUNTY
9 OF BUTTE-SILVER BOW, STATE OF MONTANA:

10 WHEREAS, Pursuant to Chapter 13.08 of the Butte-Silver Bow
11 Municipal Code, the total annual rate of charge
12 for metro sewer user fees shall be set by the
13 Council of Commissioners in an annual metro sewer
14 rate resolution.

15 BE IT RESOLVED BY THE COUNCIL OF COMMISSIONERS OF THE CITY- COUNTY
16 OF BUTTE-SILVER BOW, STATE OF MONTANA:

17 SECTION 1: That the sewer rates and service charges necessary
18 to raise the amount for operation and maintenance
19 of the Metro Sewer Sanitary and Storm Sewer System
20 and for operation and maintenance of the Metro

1 Sewer Treatment Plant by the City-County of Butte-
2 Silver Bow to defray the cost of environmentally
3 mandated improvements for the fiscal year 2018,
4 all as set out in the annual budget are hereby
5 fixed at the following rate per unit user:
