

COUNCIL RESOLUTION NO. 17-54

1 A RESOLUTION FIXING AND ESTABLISHING METRO STORM WATER UTILITY  
2 RATES AND SERVICE CHARGES FOR THE OPERATION, MAINTENANCE AND  
3 CAPITAL IMPROVEMENTS OF THE METRO STORM SEWER SYSTEM BY THE CITY-  
4 COUNTY OF BUTTE-SILVER BOW, MONTANA FOR FISCAL YEAR 2018 AND  
5 PROVIDING FOR AN EFFECTIVE DATE HEREIN.

6 BE IT RESOLVED BY THE COUNCIL OF COMMISSIONERS OF THE CITY-COUNTY  
7 OF BUTTE-SILVER BOW, STATE OF MONTANA:

8 WHEREAS, Pursuant to Chapter 13.32 of the Butte-Silver Bow  
9 Municipal Code, the total annual rate of charge  
10 for metro storm water utility user fees shall be  
11 set by the Council of Commissioners in the annual  
12 metro storm water utility rate resolution.

13 BE IT RESOLVED BY THE COUNCIL OF COMMISSIONERS OF THE CITY- COUNTY  
14 OF BUTTE-SILVER BOW, STATE OF MONTANA:

15 SECTION 1: That the storm water rates and service charges  
16 necessary to raise the amount for operation and  
17 maintenance of the Metro Sewer Storm Sewer System  
18 by the City-County of Butte-Silver Bow to defray  
19 the cost of environmentally mandated improvements  
20 for the fiscal year 2018, all as set out in the

1 annual budget are hereby fixed at the following  
2 rate per unit user:
